4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Effects may be delayed. Remove person from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow person to assume most comfortable position and keep warm. Keep at rest until fully recovered. If breathing laboured and person cyanotic (blue), ensure airways are clear and have a qualified person give oxygen through a facemask. If breathing has stopped apply artificial respiration at once. In the event of cardiac arrest, apply external cardiac massage. Seek immediate medical attention.

Skin Contact: If skin or hair contact occurs, remove contaminated clothing immediately and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

Eye contact: If in eyes, hold eyelids apart and flush the eyes continuously with running water. Continue flushing until advised to stop by the Poisons Information Centre or a doctor; or for at least 15 minutes and transport to doctor or hospital.

Ingestion: Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink. Never give anything by the mouth to an unconscious person. If vomiting occurs give further water. Seek medical advice.

PPE for First Aiders: Wear safety shoes, overalls, gloves, safety glasses. Available information suggests that gloves made from butyl rubber, natural rubber, nitrile rubber, neoprene, polyvinyl alcohol (PVA) or polyvinyl chloride (PVC) should be suitable for intermittent contact. 5. FIRE FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

Minor spills can be rinsed with water and do not normally need any special clean-up measures, however it is a safety precaution to wear protective equipment to prevent skin and eye contamination. Wear protective equipment to prevent skin and eye contamination. Avoid inhalation of vapours or dust (from dried product). Wipe up with absorbent (clean rag or paper towels). Collect and seal in properly labelled containers or drums for disposal.

LARGE SPILLS

Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation. Do not dilute material, instead contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Dispose of waste according to applicable local and national regulations. If contamination of crops, sewers or waterways has occurred advise local emergency services.

7. HANDLING AND STORAGE

Handling: Avoid eye contact and repeated or prolonged skin contact. Avoid inhalation of vapour, mist or aerosols. Avoid contact with incompatible materials. When handling DO NOT eat, drink or smoke. Avoid physical damage to containers.

Storage: Store in a cool, dry, well-ventilated place and out of direct sunlight. Protect from freezing. Store away from foodstuffs. Store away from incompatible materials described in Section 10.
